VRS Students Return to Class on Monday, Aug. 27

The 2017-2018 school year was a big one for Vern Riffe School, which saw an end to classes for the year May 23.

"The students and staff at Vern Riffe School had a wonderfully productive year full of learning and fun," said Principal Tammy Guthrie. "Many thanks to our community partners who made students' experiences this year at VRS even better, including LifePoint Church, Southern Ohio Medical Center, and Sierra's Haven for New and Used Pets."

The school served 63 students throughout the year from 10 Scioto County school districts, including seven students who were new to Cardinal Country.

Education is individualized at VRS and based on Ohio's Learning Standards, functional, and adaptive needs. Therapy staff provides related services, including speech and language pathologists, occupational therapy, physical therapy, and adaptive physical education. Students, in addition to the academic curriculum, have jobs in the classroom or within the school.

In addition to class and school activities, many students were also active in Scioto County Special Olympics, Girl Scouts, and 4-H. Be sure to check out the Girl Scouts display at the Scioto County Fair!

Legislative Corner

HB 572/RETIREMENT CREDIT (Scherer, G., Howse, S.) Regarding Public Employees Retirement System service credit for services as a nonteaching school employee of a county board of developmental disabilities. (CONTINUED; 1st Hearing-Sponsor)

Rep. Howse and Rep. Gary Scherer (R-Circleville) presented joint sponsor testimony.

Scherer said the bill makes sure certain county board of developmental disabilities employees who work through academic year receive a full year of retirement credit. He said the measure responds to a reversal of a 30-year policy that mainly impacts teacher assistants and bus assistants involved in county board of DD schools and early childhood programs.

"This legislation will require the OPERS Board to grant a full year of service credit to a

member employed as a nonteaching school employee of a county board of developmental disabilities if the member performs full-time services in the position for at least nine months of the year and is paid earnable salary in each month of that year," he said.

Without the change, a new teacher assistant would have to work 36 years to achieve the equivalent of 30 full years of service.

Howse said the bill is needed to establish parity in the retirement service credit system. She said the estimated 1,300 impacted employees generally earn low salaries, with average pay for teacher assistants at \$9.81 per hour and average pay for bus aides at \$9.61 an hour.

Scherer said the provision was included in a prior bill dealing with cost of living adjustments, but didn't become law.

He also told Rep. Merrin the process of granting a full year of credit had been in place for many years, but auditors indicated it wasn't specifically allowed by law.

Rep. Scott Wiggam (R-Wooster) asked whether those impacted by the bill would purchase additional credit to get the full year.

Scherer said there wouldn't be a purchase of service credit, adding that money that funds the benefit is already withheld from employee paychecks.

Rep. Brigid Kelly (D-Cincinnati) suggested the issue is similar to how lawmaker pensions are calculated, with members being given a full year of service credit even though there are typically no voting sessions in the summer.
