
Scioto County Developmental Disabilities provides a lifetime of supports for those individuals found eligible. We serve Scioto County residents of all ages who have intellectual, physical, and developmental disabilities. In 2017, more than 800 individuals and families were served by SCDD programs such as Early Childhood, Vern Riffe School, Service & Support Administration, and Adult Services. The trend is for more of our friends and neighbors right here in Scioto County to need services in coming years.

In 2017, SCDD continued updating facilities with the capital improvement plan, which included the replacement of roofs at the Carousel Center, STAR, and Vern Riffe School. A new ramp was added to the Gallia Street entrance of Vern Riffe School, providing a second accessible entrance to the historic building.

The Early Childhood Program based at the Carousel Center has begun utilizing the Primary Service Provider model of service provision for all families who have an infant or toddler enrolled in our birth-to-3 program. This model facilitates a team approach to all services provided. In the PSP model, the Developmental Specialists work closely with Help Me Grow staff, a speech pathologist, an occupational therapist, and a physical therapist for each child served by the Early Intervention system.

> At Vern Riffe School education is individualized, based on Ohio's Learning Standards, functional and adaptive needs. Therapy staff provides related services, including speech and language, occupational, and physical therapies, as well as adaptive physical education. In addition to the academic curriculum, students also have jobs in their classroom or in the school environment. VRS served 63 students in the school year, graduating four students.

> > Adult Day Services, based at STAR, offered many more transportation options for individuals served with three new routes. The 2017 Community Employment Program saw 75 individuals employed in Scioto County and served a total of 95 individuals. This is growth of more than 200 percent since 2015!
